

Liste annotée des participants à la réunion des Bilderberger 2015

This year's Bilderberg conference is about Iran. That conclusion screams at anyone who goes beyond the first line of the Bilderberg press hand out. That is why I publish an annotated guide to the Bilderberg Society. John Sawers was invited because he was the former head of MI-6 not because in retirement he has a consulting group. Or the man listed as a distinguished visiting lecturer was actually 'Mad Dog' Mattis, the retired Marine General who had commanded US Central Command. Many of the participants are listed as diplomats or professors. Dig a little deeper. They are Iranian and Arab experts. Or they are diplomats who worked in the Mideast. One was an ambassador to Syria.

I noticed a lot of Turks coming to this conference. I think Bilderberg wants to use Turkey to help solve their perceived Iranian problem. No indication yet what they plan to do. I have concluded that Iran's advanced S-300 anti-aircraft system will soon be fully operational. They started building it months before Russia said they would give them an upgraded system. That is a Game Changer.

I see zero Bilderberg interest in a war with Russia or China.

Some are there to make money. Some are there because they have trillions of dollars from wealthy clients which they manage in Hedge Funds. Those are easy to spot. A Turkish lawyer specializes in mergers. An Austrian property developer has deals galore in prime European locations.

A lot of Bilderberg interest is in managing the EU, the UK and the US political and economic scene. This conference is loaded with Clinton supporters. Bilderberg is backing the wrong horse if they think Hillary Clinton is going to win the 2016 elections.

Bilderberg has been bringing High Tech into their fold. That is continuing. They brought in an AI expert from Google. That are very much interested in using High Tech to spy 24/7 on us.

FRA Castries, Henri de Chairman and CEO, AXA Group, the insurance giant is the 9th largest company in the world. He replaced Viscount Etienne Davignon three years

ago. An American unit of AXA was involved in the Wall Street fleeces Main Street scandal which was investigated by the New York state Attorney General. He is Chairman of Bilderberg.

DEU Achleitner, Paul M. Chairman of the Supervisory Board, Deutsche Bank AG. Deutsche bank had been key to manipulating currencies, interest rates, silver and gold. Deutsche Bank used to participate in the London silver and gold fix. That ability to fix prices has been given to China as will the addition of the yuan as the fifth currency in the IMF's basket of currencies in the SDR. That means Bilderberg is accepting Dollar Devaluation. Member of Bilderberg Steering Committee.

GBR Agius, Marcus Non-Executive Chairman, PA Consulting Group. His wife is Katherine de Rothschild. Her father is Evelyn de Rothschild who was a co-founder of Bilderberg. Agius began his career at the Rothschild associated Lazard bank. Member of Bilderberg Steering Committee.

DNK Ahrenkiel, Thomas Director, Danish Intelligence Service (DDIS). He is there because of his job. He has no Bilderberg history.

USA Allen, John R Special Presidential Envoy for the Global Coalition to Counter ISIL (ISIS), US Department of State. He is there because ISIS is on the agenda. ISIS works for the CIA and the Mossad. They have been attacking Hamas in Gaza. No real Muslim would work for Israel and the CIA. He is a retired Marine Corps General who served in Afghanistan. He said it might take a year to get the Iraqi Army into shape. This is the same State Dept that said last week Syria was an ally of ISIS. The US plan came from Israel. It is to divide Iraq into 3 parts and to destroy Syria so Israel can expand past Lebanon to the Tigris.

USA Altman, Roger C Executive Chairman, Evercore Partners. He used to be with Lehman Brothers and Blackstone Group. He is a key supporter of Hillary Clinton. He was an adviser on the GM bankruptcy collecting \$46 million in fees for Evercore. He is a member of the Council on Foreign Relations. He is a Democratic party and Clinton insider. Member of Bilderberg Steering Committee.

POL Applebaum, Anne Director of Transitions Forum, Legatum Institute. This institute works for advancing reforms. They want to help Iran transition to a future designed by the Bilderberg Society. Iran is an Agenda item this year.

FIN Apunen, Matti Finnish Business and Policy Forum EVA He supports globalization of business and media. He is a member of the Bilderberg Steering Committee.

USA Baird, Zoë CEO and President, Markle Foundation. She is famous for being turned down for Attorney General due to Nannygate. She is a lawyer and Clinton insider. You might remember that Kimba Wood was Clinton's second choice for AG. She has been accused of letting Junk Bond King Michael Milken keep \$5 billion from bankruptcy court.

GBR Balls, Edward M. Former Shadow Chancellor of the Exchequer. He lost re-election in 2015. He is an Oxford graduate. He used to write for Financial Times, a Bilderberg favorite. His wife is still an MP and a member of the Labour Shadow Cabinet. He is a returning member.

PRT Balsemão, Francisco Pinto Chairman, Impresa SGPS. Former Prime Minister. He is the founder of a weekly news magazine. He is a broadcaster and has business ties with Brazil. Also a returning member.

Barroso, José M. Durão Former President of the European Commission. He is a Member of Bilderberg Steering Committee.

FRA Baverez, Nicolas Partner, Gibson, Dunn & Crutcher LLP. He works at the Paris office of an international law firm headquartered in New York with 1,000 lawyers and offices in 17 nations. He specializes in privatization meaning he takes utilities that were paid for by the public and gives them to billionaires. Tolls and fees are charged to taxpayers. Bilderbergers love privatization. Member of Bilderberg Steering Committee.

AUT Benko, René Founder, SIGNA Holding GmbH. He runs the largest real estate holding company in Austria. He has expanded into European prime center real estate. Billionaires are making lots of money in real estate in select markets. That is why he is there.

ITA Bernabè, Franco. Chairman, FB Group SRL (His Investment Group) Former Chairman Telecom Italia. He had to resign as CEO because share prices slumped. He is a non-executive director of Petro China. He was appointed as Vice Chairman of Rothschild Europe. He is on the Bilderberg Steering Committee. The other Bilderberg

participants merely discuss the agenda until agreement is reached. The Steering Committee sets that agenda. Notice how close the Steering Committee is to the Rothschild family. Notice also the close ties to China.

NLD Beurden, Ben van CEO, Royal Dutch Shell plc. Shell oil is owned by the Rothschilds and by the Dutch Royal family amongst others. He cut a lot of employees but left his technology group untouched.

FRA Bigorgne, Laurent Director, Institut Montaigne This is a French Think Tank. It has two Bilderbergers on the board. They want people to accept new idea and to work together as long as you believe the lies they tell.

FRA Boone, Laurence Special Adviser on Financial and Economic Affairs to President Hollande. She used to be Bank of America's Chief economist. Her job is to make sense out of French economic policy. Bilderberg wants her to rescue France for the EU and the Rothschilds.

ESP Botín, Ana P. Chairman, Banco Santander. Formerly head of Santander UK. This is an old drug money laundering bank with ties to Latin America and the Rothschilds. Her mother is of Irish descent. She worked for J P Morgan for 8 years.

NOR Brandtzæg, Svein Richard President and CEO, Norsk Hydro ASA. It is the fourth largest integrated electrical generation and aluminum producer in the world. Member of Bilderberg Steering Committee.

AUT Bronner, Oscar Publisher, Der STANDARD Verlagsgesellschaft m.b.H., a nationwide newspaper. He is Jewish and was born in Israel. He is a returning participant.

USA Burns, William President, Carnegie Endowment for International Peace. He was a professional US diplomat. He speaks Arabic, Russian and French. Foundations are important but if you want someone who has been an ambassador to the Russians and to Arabs, then he is your expert. They are looking for solutions to Iran's resistance to the NWO.

FRA Calvar, Patrick Director General, DGSI. This is the French intelligence service. The Europeans in Bilderberg want experts on the Mideast who were not tainted by America.

ESP Cebrián, Juan Luis Executive Chairman, Grupo PRISA. They own radio and TV stations are in publishing as well. They are owned by the Phoenix Group, a British insurance company. Member of Bilderberg Steering Committee.

CAN Clark, W. Edmund Retired CEO, TD Bank Group (Toronto Dominion Bank) He is a member of the all important Bilderberg Steering Committee. He believes strongly in sustainable communities. The Rothschilds, the British Royals and many other Brits have substantial investments in Canada.

INT Coeuré, Benoît Member of the Executive Board, European Central Bank. He is in charge of monetary operations and supports Mario Draghi's interest rate policies. He is a French citizen and professional civil servant.

CAN Coyne, Andrew Editor, Editorials and Comment, National Post. Bilderberg brings media into meetings to control what we read about their meetings. He never attended before.

SWE Damberg, Mikael L. Minister for Enterprise and Innovation. Never attended before. He is a Social Democrat. And he is a professional politician. He never attended before.

BEL De Gucht, Karel Former EU Trade Commissioner, State Minister. They chose him to present EU trade relations to the Group. These people are the NWO. They love the TPP and TTIP treaties. Member of Bilderberg Steering Committee.

NLD Dijsselbloem, Jeroen Minister of Finance. Former President of the Eurogroup and the current Governor of the European Stability Mechanism. In other words he was the poster boy for Austerity. First time participant.

USA Donilon, Thomas E. Former U.S. National Security Advisor; Partner and Vice Chair, O'Melveny and Myers LLP. This international law firm represents many corporations associated with Bilderberg. He is a lawyer and worked as a lobbyist for Fannie Mae. Donilon has no military experience but was intimately involved in many major foreign policy issues, including negotiating the Bosnian peace agreement and the expansion of NATO. His predecessor at NSA General Jones criticized his poor handling of staff and lack of experience. He made up for his lack of overseas experience by joining Obama on his surprise 6 hour trip to Afghanistan. Donilon was a key architect of Obama's Afghanistan policy and we can see how well worked. His 5

fold escalation of the use of drones did NOT improve America's image there and in Pakistan. His wife and his brother work for VP Joe Biden. Returning member.

DEU Döpfner, Mathias CEO of Axel Springer SE, the German media group. Returning member.

GBR Dowling, Ann President, Royal Academy of Engineering. First time participant. She works on making Jets quieter. She is on the Board at BP.

USA Dugan, Regina Vice President for Engineering, Advanced Technology and Projects, Google. Former Director of DARPA. Another strong ties between DARPA and Google. She promotes ingestible RFID chips.

NOR Eilertsen, Trine Political Editor, Aftenposten.

DNK Eldrup, Merete. CEO, TV 2 Danmark A/S. She is locally important in Denmark.

USA Elkann, John Chairman, Fiat S.p.A. He is the grandson and heir of Gianni Agnelli. Fiat owns Lancia, Ferrari, Maserati and Chrysler. Elkann is Jewish and was born in New York. He also runs the Agnelli family investment firm Exor which owns Juventus F.C., Cushman; Wakefield and SGS. Henry Kissinger, Carla Bruni, and Ell McPherson attended his wedding. FIAT is an integral part of the NWO. Returning participant.

DEU Enders, Thomas CEO, Airbus Group. Airbus is facing financial difficulties. Member of Bilderberg Steering Committee. They make military hardware as well.

USA Erdoes, Mary CEO, JP Morgan Asset Management. She manages \$2.2 trillion for the Uber Rich. Bilderbergers are billionaires and are worried about their money. She knows Jamie Dimon and the Clintons. New participant.

GBR Fairhead, Rona Chairman, BBC Trust. They need to change their name. I do not trust the BBC. New participant.

DNK Federspiel, Ulrik. Executive Vice President, Haldor Topsøe A/S. They make advanced technology for the oil industry. Oil is an important investment for Bilderberg. Member of Bilderberg Steering Committee.

USA Feldstein, Martin S. President Emeritus, NBER; Professor of Economics, Harvard University. This is the man who can tell you when the bottom falls out of the market. These people either are or work for the wealthy elite. They need a better idea of when everything hits the wall.

USA Ferguson, Nial Professor of History, Harvard University, Gunzberg Center for European Studies. He was born in Glasgow and graduated from Oxford. He is an official biographer of Henry Kissinger and has written about the Rothschild family . He represents the latter at Bilderberg. He is an economic historian and one of his areas of expertise is Hyperinflation. He has said the euro is doomed and can only be saved by more centralization (and less democracy). We will all become experts in Hyperinflation at the rate at which the Bilderbergers are printing money. They are intentionally creating more debts so taxpayers will all become permanent debt slaves. Returning member.

AUT Fischer, Heinz Federal President of Austria. He is making the taxpayers pay for Bilderberg security. New participant.

GBR Flint, Douglas J. HSBC is an old drug running bank better known as Hong Kong Shanghai Bank. Asia Times tells us that the big banks launder 500 billion dollars a year in bribes and that 40% of that money belongs to Chinese politicians. His bank has extensive contacts with both Chinese politicians and Latin American drug cartels. They also were in the LIBOR scandal. Returning member.

CHE Franz, Christoph Chairman of the Board, F. Hoffmann-La Roche Ltd New participant. His company is one of many major cogs in the NWO machine.

NLD Fresco, Louise O. President Wageningen University and Research Centre. New participant. She is a member of the Trilateral Commission and she specializes in 'sustainable development.' That is a hot topic for the NWO. She serves on major corporate boards.

USA Griffin, Kenneth Founder and CEO, Citadel Investment Group, LLC. He is a successful Hedge Fund manager. He has donated \$500 million to charity including \$150 million to Harvard. He is likely there because he is an expert at reforming financial regulations. The US SEC is worthless. New participant.

ITA Gruber, Lilli Executive Editor and Anchor “Otto e mezzo”, La7 TV. She is a native speaker of Italian and German. She was critical of Berlusconi, quit her state TV job and became a Euro MP. She returned to TV. She is fluent in English and has worked as a war correspondent. Returning member. She is popular with Bilderberg.

RUS Guriev, Sergei Professor of Economics, Sciences Po. (Used to be known as Institute of Political Studies.) He is an economist. He fled Russia in 2013. His troubles began when he supported Mikhail Khodorkovsky. Russia is a minor issue at Bilderberg. He cannot broker a peaceful solution. He writes columns for Forbes and an op-ed for the NY Times.

Tur Gürkaynak, Gönenç Managing Partner, ELIG Law Firm. His firm specializes in mergers. This means they operate at the highest levels in Turkey. He is there to make money for expanding firms not to advise on ISIS. New participant.

AUT Gusenbauer, Alfred Former Chancellor of the Republic of Austria. Since then (2008) he has pursued a career as a consultant and lecturer, and as a member of supervisory boards of Austrian companies. New participant.

NLD Halberstadt, Victor Victor Professor of Economics, Leiden University. Former Honorary Secretary General of Bilderberg Meetings. Member of Bilderberg Steering Committee.

AUT Hampel, Erich Chairman, UniCredit Bank Austria AG. New participant. UniCredit is a European bank headquartered in Milan. They are a powerful group. The billionaire families of Northern Italy are an important part of the NWO.

GBR Hassabis, Demis Vice President of Engineering, Google Deep Mind. He is an expert in AI. He was a world class game developer and chess champion before he earned a PhD in Cognitive Neuroscience. He is British. New participant. Bilderberg is interested very much in his work.

AUT Hesoun, Wolfgang CEO, Siemens Austria. Siemens is also a major NWO cog. He is an Austrian.

CHE Hildebrand, Philipp Vice Chairman, BlackRock Inc. This Hedge Fund manages nearly \$5 trillion in assets. He is managing some Bilderberg member funds. New participant.

USA Hoffman, Reid Co-Founder and Executive Chairman, LinkedIn. New participant. Bilderberg is drawing in High Tech firms.

INT Ischinger, Wolfgang Chairman, Munich Security Conference. This is an annual conference that brings together CEOs and heads of state and other decision makers to discuss security. New participant. Bilderbergers stole tens of trillions of dollars from us. They are worried that we might revolt when they tell us that half of the people in Europe and North America will have to give up eating regular meals.

USA Jacobs, Kenneth M. Chairman and CEO of Rothschild owned Lazard. Member of Bilderberg Steering Committee.

DEU Jäkel, Julia CEO, Gruner + Jahr. It is the largest European printing and publishing firm. She is a graduate of Heidelberg and Cambridge universities. New participant.

USA Johnson, James A. Chairman, Johnson Capital Partners. He selects VP candidates for the Democrats. He had something of a mortgage scandal in 2008. He has real power within the Democratic party. He typically selects the VP candidate for the Democrats. Member of Bilderberg Steering Committee.

FRA Juppé, Alain Mayor of Bordeaux, Former Prime Minister. He is a potential President candidate for the Right Wing UMP party which is pro EU. New participant to the best of my knowledge but he could have attended years ago before I started collecting lists.

DEU Kaeser, Joe President and CEO, Siemens AG. Worked at Siemens branch in Silicon Valley. He is a financial officer and administrator. He went to Russia to emphasize the importance of trade at a time when sanctions were being urged. New participant.

USA Karp, Alex CEO, Palantir Technologies. This high tech company was created with seed money from the CIA so I do not believe those claims about protecting user privacy. Any more than I would from all the other high tech companies the CIA funded. Member of Bilderberg Steering Committee.

FRA Kepel, Gilles University Professor, Sciences Po. (Used to be known as Institute of Political Studies.) He is an expert on Islam and the contemporary Arab world. He is there to discuss ISIS. New participant.

GBR Kerr, John Deputy Chairman, Scottish Power Independent Member, House of Lords and Deputy Chairman of Royal Dutch Shell He was a professional diplomat and ambassador to Russia, the US Pakistan and the EU. He is a director of Rio Tinto, a Rothschild company. Member of Bilderberg Steering Committee.

TUR Kesici, Ilhan MP, Turkish Parliament. Member of opposition CHP. He is an expert on NATO. New participant.

USA Kissinger, Henry Kissinger, Henry A. Chairman, Kissinger Associates, Inc. Kissinger is wanted for war crimes. He is a very big supporter of population reduction (i.e. killing billions of poor people.) Lest you think you are exempt please note that in a Hyperinflation your wages will be cut in half for openers and things will go down hill from there. In Argentina middle class families fed themselves from what they found in garbage cans.

USA Kleinfeld, Klaus Chairman and CEO, Alcoa and former CEO of Siemens AG. though he had to quit Siemens over corruption charges. He is a member of the board of directors of Citigroup and Bayer. He is popular with the bankers. Member of Bilderberg Steering Committee.

NLD Knot, Klaas H.W. President, De Nederlandsche Bank. He was appointed by the crown. Klaas Knot has been President of DNB since 1 July 2011. By virtue of his position, he holds seats on the Governing Council and General Council of the European Central Bank, as well as on the Financial Stability Board, besides being a Governor of the International Monetary Fund. Also on board of the BIS. Returning member.

TUR Koç, Mustafa V. Chairman, Koç Holding A.S. He was the only son of Turkey's wealthiest man. He graduated from Johns Hopkins in the USA. His company is the largest in Turkey and partners with many foreign corporations making light bulbs and cars. He is a member of the New York Yacht Club. He hired Peter Sutherland a former Head of Bilderberg Europe. Member of Bilderberg Steering Committee.

AUT Kogler, Konrad Director General, Directorate General for Public Security. New participant.

USA Kravis, Henry R. Co-Chairman and Co-CEO, Kohlberg Kravis Roberts & Co. When they bought R J Reynolds, Catherine Austin Fitts couldn't understand how they could pay so much. She learned that Reynolds sold cigarettes to terrorists and drug dealers so they could launder money. They take over companies and steal their pensions. Returning member.

USA Kravis, Marie-Josée Senior Fellow and Vice Chair, Hudson Institute (founded by Herman Kahn). It is funded by Eli Lilly. She is from Montreal, Quebec, and is the third wife of financier Henry Kravis. She is an economist and serves on the board of major corporations. Member of Bilderberg Steering Committee.

CHE Kudelski, André Chairman and CEO, Kudelski Group. He is a member of the powerful Bilderberg Steering Committee. He serves on many corporate boards.

DEU Lauk, Kurt President, Globe Capital Partners. Former Euro MP. He used to work for Boston Consulting Group. (As did Romney and Netanyahu) He is a power within German industry. He advises Angela Merkel he is to her right and wants more austerity. New participant.

SWE Lemne, Carola CEO, The Confederation of Swedish Enterprise. She is a doctor and runs the largest private practice group within Swedish healthcare. New participant.

USA Levey, Stuart Chief Legal Officer, HSBC Holdings plc Mr Levey was a Senior Fellow for National Security and Financial Integrity at the Council on Foreign Relations. He was the first Under Secretary for Terrorism and Financial Intelligence in the US Department of the Treasury, serving from July 2004 to February 2011 under Presidents Bush and Obama. New participant.

DEU Leyen, Ursula von der Minister of Defense. New participant.

Bel Leysen, Thomas Chairman of the Board of Directors, KBC Group. This is a European bank which has expanded along with the EU into eastern Europe. Member of Bilderberg Steering Committee.

GBR Maher, Shiraz Senior Research Fellow, ICSR, King's College London. New participant. He is a real expert on modern Arab movements. He is there to discuss ISIS.

DNK Markus Lassen, Christina Head of Department, Ministry of Foreign Affairs, Security Policy and Stabilization. She was Danish ambassador to Jordan and Syria. She is another ISIS expert. New participant.

USA Mathews, Jessica Tuchman. Distinguished Fellow, Carnegie Endowment for International Peace. Member of Bilderberg Steering Committee. She is a permanent fixture at Bilderberg showing the importance of the Foundations to the bankers. The Foundations and federal grants enable control of the universities.

USA Mattis, James Distinguished Annenberg Visiting Fellow, Hoover Institution, Stanford University. This is General 'Mad Dog' Mattis, former USMC and Commander Central Command. He is there to talk about ISIS. New participant.

CHE Maudet, Pierre Department of Security, Police and the Economy of Geneva. New participant. Former mayor of Geneva. In America he would be called a Libertarian.

CAN McKay, David I. President and CEO, Royal Bank of Canada. New participant. Bilderbergers love Bankers. That is why he is there.

TUR Mert, Nuray She is a columnist, Professor of Political Science, Istanbul University. New participant. Critic of President Erdogan. Turkey might be a key to solving ISIS.

USA Messina, Jim CEO, The Messina Group. He ran the Obama 2012 campaign and advised the UK Tory 2015 campaign. He is there because Bilderberg wants to control the 2016 Presidential elections. New participant.

BEL Michel, Charles Prime Minister of Belgium. New participant.

USA Micklethwait, John Editor-in-Chief, Bloomberg LP. Used to be Editor-in-Chief, The Economist which is owned by the Rothschilds. The Economist urged Iraq to attack Iran 6 months before the war started. Returning member.

GBR Minton Beddoes, Zanny Editor-in-Chief, The Economist, a Rothschild publication. New participant.

ITA Monti, Mario. Senator-for-life; President, Bocconi University. He was the former European Commissioner and VP for Goldman Sachs who was appointed Prime Minister of Italy. He has been a member of the Trilateral Commission and a Member of the Bilderberg Steering Committee.

FIN Mörntinen, Leena Executive Director, The Finnish Family Firms Association. New participant. Has PhD in political science. Former MP.

USA Mundie, Craig J. Senior Advisor to the CEO, Microsoft Corporation. Member of the Bilderberg Steering Committee. Mundie advocates that individuals be licensed before being allowed to use the Internet.

CAN Munroe-Blum, Heather Chairperson, Canada Pension Plan Investment Board. Formerly, Professor of Medicine and Principal (President) Emerita, McGill University. She holds a Ph.D. in epidemiology from the University of North Carolina at Chapel Hill and has researched the epidemiology of psychiatric illness whatever that means for us. She is a member of the Trilateral Commission and serves on the Board of Directors of the Royal Bank of Canada. She advises governments on issues relating to young people. Returning member. That pension fund she manages is not safe.

NLD H.R.H. Princess Beatrix of the Netherlands. Her family owns a large part of Royal Dutch Shell along with the Queen of England and the Rothschilds. Forbes magazine did a puff piece and said she had only 300 million dollars. This is not credible for a family that ruled for 200 years. She was replaced by her son Wilhelm-Alexander.

IRL O'Leary, Michael CEO, Ryanair Plc. New participant.

GBR Osborne, George First Secretary of State and Chancellor of the Exchequer. He and Cameron came up with this idiotic Help to Buy scheme purloined from Alan Greenspan. It got them past election day. The UK has more Unpayable Debts to cancel than the US. The next Depression will hit them harder than the US.

TUR Özel, Soli Columnist, Haberturk Newspaper; Senior Lecturer, Kadir Has University. He edits a Turkish language edition of Foreign Affairs magazine. He is Turkish of Jewish origins. Turkey is important this year because of ISIS. Returning member.

GRC Papalexopoulos, Dimitri Group CEO, Titan Cement Co. Titan cement is a large international company which is expanding into the US and eastern Europe. He also appeared at Davos and likes to talk in public. Returning member.

FRA Pégard, Catherine President, Public Establishment of the Palace, Museum and National Estate of Versailles. She is a long time journalist prior to this latest cultural appointment. She was a Sarkozy supporter. New participant.

USA Perle, Richard N. Resident Fellow, American Enterprise Institute. Member of the Bilderberg Steering Committee. He was a member Project for the New American Century (PNAC) . He went to Israel where he accepted citizenship and wrote “A Clean Break: A New Strategy for Securing the Realm” for PM Netanyahu. This was written into PNAC and became US doctrine in the early Bush years. PNAC documents spoke of a need for a new Pearl Harbor before 911. A Clean Break advocated invasion of Iraq for regime change. Bush did that for Israel in 2003. A Clean Break also advocated the use of proxy armies to attack Syria over the issue of chemical weapons. Obama has been doing that for Israel for the past 4 years. There are no moderate rebels. They killed 100,000 Christians. The DIA has admitted they run ISIS. The US bombed Iraqi soldiers in battles at Tikrit and Fallujah. The US is air dropping supplies to ISIS.

CAN Reisman, Heather M. Chair and CEO, Indigo Books and Music Inc, the largest bookstore chain in Canada. Her husband, Gerry Schwartz, runs Onex, a leading venture capital firm. She is listed as a member of the Steering Committee of the Bilderberg Group. She and her husband switched from Liberal to Conservative over

the Israel Lebanon war. PM Harper's Chief of Staff used to work for her husband. Her uncle was the first Canadian to work with Bilderberg to break up Canada to get it into the North American Union.

ITA Rocca, Gianfelice Chairman, Techint Group. This is a worldwide steel producer with 24 billion dollars in annual sales. Returning member.

AUT Roiss, Gerhard C EO, OMV Austria. Petrochemicals company. Austrian branch manager. New participant.

USA Rubin, Robert E Co-Chair, Council on Foreign Relations; Former Secretary of the Treasury. He was head of Citibank's private bank which launders drug money. In 1999 Robert Rubin, Alan Greenspan, Larry Summers (Samuelson) and Arthur Levitt told Brooksley Born of the CFTC that she could not regulate Credit Default Swaps which were faux insurance. They were unregulated and did not require the seller to set aside money to pay claims. All sales income could be paid out in bonuses allowing the taxpayer to foot the bill when it came due as it did in AIG. USA Schmidt, Eric E. Executive Chairman, Google Inc. He has worked at Sun and Apple. Google is a superior search engine and was designed that way by the CIA-DARPA hive. It was given to the founders as was a lot of new technology. It is given on the condition that the CIA and NSA are allowed to spy on us. He is a Returning member.

AUT Scholten, Rudolf CEO, Oesterreichische Kontrollbank AG. He is head of the Austrian Central Bank. INT Stoltenberg, Jens Secretary General, NATO. He is definitely there for Iran. They must talk about NATO and Russia but this conference is about Iran. New participant.

FIN Stubb, Alexander Prime Minister of Finland. He has a PhD from London School of Economics. He speaks 5 languages and is an athlete. Nice man except he supports the EU. He estimated the EU spends 511 million euros a year on translations. New participant.

DEU Suder, Katrin Deputy Minister of Defense for Germany. She has a degree in physics and worked for McKinsey consulting until going to work for the Ministry of Defense modernizing organization and increasing usage of IT. New participant.

IRL Sutherland, Peter D. Chairman, Goldman Sachs International; UN Special Representative for Migration. He was Ireland's youngest Attorney General. He was appointed European Commission for Competition. He was called 'the father of

globalization' for his service as Director of what became the World Trade Organization. He is on the Bilderberg Steering Committee. He is a former Chairman of the Trilateral Commission. As the UN's (Bilderberg) special representative for migration, he told the EU that they should "do its best to undermine" the "homogeneity" of its member states. As an Irishman who was a good footballer in his 20s, he should be ashamed of himself. He is a Returning member.

SWE Svanberg, Carl-Henric Chairman, BP plc; Chairman, AB Volvo. He is a Returning member.

Nor Svarva, Olaug CEO, The Government Pension Fund Norway. New participant. Pension funds are a primary target for Bilderberg.

USA Thiel, Peter A. President of Thiel Capital. Thiel is on the Bilderberg Steering Committee and is bringing in the younger crowd of high tech billionaires the CIA and NSA will need to end anonymity on the Internet and then close down free speech. It should be noted that he is not an engineer. He is a lawyer and Stanford graduate. He worked as a derivatives trader and runs a Hedge Fund. He owned 10.2% of Facebook pre IPO. Thiel is a founder of PayPal which shuts down service to those who practice free speech on the Internet. He was an early investor in Facebook which legally should never had been offered as an IPO at anything above a dollar a share. PayPal has been linked by John Cruz to money laundering.

GRC Tsoukalis, Loukas President, Hellenic Foundation for European and Foreign Policy. He has written on European expansion which he accepts. He just wants them to not forget democracy and social welfare as Europe becomes a single state. He needs to look at the European Commission. They are not democratic. And he can forget social welfare. Please Sir, take a look at the people of Athens. What you see is what you will get more of. He signed a petition asking European leaders for leniency in the case of Greece. Member of the Bilderberg Steering Committee.

INT Üzümcü, Ahmet Director-General, Organization for the Prohibition of Chemical Weapons. He is a career Turkish diplomat. His organization won the Nobel Peace Prize in 2013.

PRT Vitorino, António M. Partner, Cuetrecasas, Concalves Pereira, RL He is a Portuguese politician from the Left battling those who want out.

SWE Wallenberg, Jacob Chairman, Investor AB. Member of the Bilderberg Steering Committee. Wealthiest family in Sweden.

USA Weber, Vin Partner, Mercury LLC. He serves on the Board of The Council on Foreign Relations and co-chaired a major independent task force on U.S. Policy Toward Reform in the Arab World with former U.S. Secretary of State Madeleine Albright. He is supposed to be a Republican.

GBR Wolf, Martin H. Chief Economics Commentator, The Financial Times. He is the favorite writer of billionaires all over the world. He is a committed Globalist. And he is Jewish. As a young man, he worried about the economic conditions of the 1930s that created the war. He should read my essays which give solutions other than more debts and more spending to solve our current crisis.

USA Wolfensohn, James D. Chairman and CEO, Wolfensohn and Company. He is most famous for being the former head of the World Bank. He was a partner of Paul Volcker and made his mark in rescuing Chrysler back in 1980. He was an Australian lawyer working for an English bank when he decided to become an American citizen so he would be eligible to become World Bank President. He is Jewish and his father had worked for the Rothschilds before immigrating suddenly to Australia.

USA Zoellick, Robert B. Chairman, Board of International Advisors, The Goldman Sachs Group. He is a lawyer and worked in the Reagan and Bush I Admins.
